What's New With Baptist Training Union

Hello, everyone! I'm your NBBC undercover reporter updating you on the things you want to know about, here at NBBC. Haven't heard much about BTU lately and thought I'd ask around. I started with Deacon Curtis the Director of NBBC BTU. I had a chance to sit down and ask him a few questions.

R: Mr. Curtis how are you?

C: Fine, thanks for asking.

R: I would like to start by asking: What is BTU and how did it get its start in the church?

C: BTU stands for Baptist Training Union. It actually started in 1888 as the Christian Co-Laborer's Society. In 1891 was changed to BYPU (Baptist Young People's Union) and in 1931 was changed once again to Baptist Training Service. It wasn't until 1934 that the term BTU was first established. Ask any senior member of NBBC and they will tell you every Sunday afternoon, BTU was a 'must' for children and adults alike. Mixed with training and teaching about the Bible, it was a true social event that was a precursor to Sunday night service.

R: Does it serve the same purpose today?

C: Somewhat; however, we are looking at focusing more on training. There are a lot of other avenues today that serve to fulfill the other aspects that BTU provided then. In 2011 we plan to start introducing monthly inform/training tips in The Spotlight and bimonthly tips in


She was predeceased by her husband, Mr. Willie Suber; daughters Betty and Mattie; sons Bobby, Charles and Odell.


